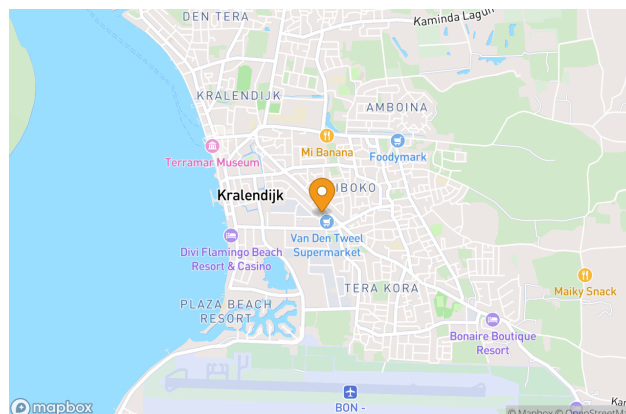

Description

The third apartment has a living room, kitchen, two bedrooms, one bathroom, a covered porch and a garden. The apartments have ceramic floor tiles throughout, aluminum window frames with glass shutters, and 220 and 110 volts.
